A. VICE MAYOR PIERRE'S REPORT:

B. COUNCILMAN DEROSE'S REPORT - CONTINUED:

C. COUNCILMAN CHERNOFF'S REPORT:

1. COUNCILMAN CHERNOFF STATED THAT HE TOO WOULD LIKE TO GIVE HIS CONDOLENCES TO THE SMITH FAMILY AND LENNY'S FAMILY. IT IS A TRAGIC LOSS THAT HER BROTHER IS NO LONGER WITH US AND HE KNOWS THAT IT IS HEARTFELT SYMPATHY FOR THE WHOLE FAMILY.

2. COUNCILMAN CHERNOFF STATED THAT HE APOLOGIZES FOR THE VETERANS THAT HE WAS NOT ABLE TO ATTEND YESTERDAY MORNING. IT IS THE FIRST TIME HE HAS EVER MISSED SINCE HE HAS BEEN ON THE COUNCIL. HE WAS NOT FEELING WELL AND HE DOES APOLOGIZE. COUNCILMAN CHERNOFF ASKED THAT KEVEN LOOK INTO BETTER SUPPORT FOR THE VETERANS IN OUR COMMUNITY, AND HE THOUGHT THEY REALLY NEED TO DO THAT. COUNCILMAN CHERNOFF STATED THAT JULES HIT A HEARTFELT STRING AND ABSOLUTELY WE NEED TO DO THAT.

3. COUNCILMAN CHERNOFF STATED THAT MRS. SMITH BROUGHT UP GREAT POINTS ABOUT WHAT THIS LEGISLATURE IS DOING TO THE SCHOOL BOARD AND THE TWO HUNDRED AND EIGHTY MILLION DOLLARS THEY HAVE TO CUT FROM THEIR BUDGET, HOW IT IS GOING TO HIT HOME TO ALL OF US IF THEY CUT RESOURCE OFFICERS, IF THEY CUT TEACHERS, IF THEY CUT TRANSPORTATION, ALL OF THAT IS GOING TO AFFECT OUR COMMUNITY. IT IS VERY HARD FOR THE SCHOOL BOARD TO GO TILL THREE O'CLOCK IN THE MORNING AND MAKE DECISIONS, BUT THEY ARE TALKING ABOUT GOING FROM TWELVE MONTHS TO TEN MONTHS, AND FOR THOSE OF YOU WHO DO NOT KNOW WHAT THAT WILL DO, THAT WILL CUT OUT A LOT OF PROGRAMS IN EVERY SCHOOL BECAUSE THEY CANNOT GEAR UP FOR THE BEGINNING OF THE YEAR. EVERY IMPACT THAT THEY MAKE TO SAVE MONEY IS GOING TO COST THE COMMUNITY. EVERYBODY NEEDS TO CALL THEIR SCHOOL BOARD MEMBER AND TELL THEM HOW IMPORTANT IT IS FOR THEM NOT TO AFFECT ANY OF THE EDUCATION OF THE CHILDREN; CUT ANCILLARY SERVICES, CUT ANYTHING THAT DOES NOT AFFECT THE CHILDREN. 15. CITY COUNCIL COMMITTEE REPORTS - CONTINUED:

C. COUNCILMAN CHERNOFF'S REPORT:

EASY FOR US TO SAY, TO CUT ANYTHING THAT DOES NOT AFFECT THE CHILDREN BECAUSE EVERYTHING AFFECTS THE CHILDREN, THE ANCILLARY SERVICES AND EVERYTHING. THE MOST IMPORTANT RESOURCE WE HAVE IS EDUCATING OUR CHILDREN, AND WE NEED TO REALLY, REALLY CALL OUR SCHOOL BOARD MEMBERS AND TELL THEM HOW IMPORTANT THAT RESOURCE IS IN ALL OF OUR COMMUNITIES AND THAT INCLUDES SAFETY, THAT INCLUDES BEING ABLE TO GET TO SCHOOL, THAT INCLUDES EVERYTHING. COUNCILMAN CHERNOFF URGED EVERYONE TO CALL YOUR SCHOOL BOARD MEMBERS AND TELL THEM NOT TO CUT ANY DOLLARS.

D. COUNCILMAN ROSNER'S REPORT:

1. COUNCILMAN ROSNER EXPRESSED HIS CONDOLENCES TO THE SMITH FAMILY. "PHYLLIS, I KNOW THAT IT IS VERY HARD AND I HOPE YOU GET THROUGH THIS VERY QUICKLY".

2. COUNCILMAN ROSNER STATED THAT HE WANTED TO GIVE EVERYONE AN FYI TODAY. HE WENT ON THE COUNTY'S PROPERTY APPRAISER WEBSITE AND NOTICED THAT THEY HAVE A PORTABILITY AREA WHERE YOU CAN ACTUALLY CLICK. YOU CAN LOOK AT YOUR ADDRESS AND YOU CAN LOOK RIGHT THERE WHERE IT SAYS "PORTABILITY" AND IT ACTUALLY GIVES YOU A WHOLE DESCRIPTION OF A NEW PROPERTY THAT YOU WOULD LIKE TO GO TO, WHAT THE MARKET VALUE IS FOR THE NEW PROPERTY, IT WILL GIVE YOU THE NEW TAXES. CONGRATULATIONS TO THE PROPERTY APPRAISER. IT LOOKS LIKE THEY ACTUALLY GOT IT TOGETHER BECAUSE EVERY TIME HE HAS ASKED, NOBODY KNOWS WHAT YOUR IMPACT WOULD BE AND YOU CAN NOW GO RIGHT THERE AND IT ACTUALLY HAS IT.

3. COUNCILMAN ROSNER STATED THAT THERE IS ONE OTHER THING THAT HE IS CONCERNED ABOUT. HE LISTENED TO MRS. SMITH TONIGHT, HE LISTENED TO EVERYBODY, REGARDING OUR POLICE DEPARTMENT. COUNCILMAN ROSNER ADDRESSED MR. KLOPP AND THAT HE IS CONCERNED ABOUT THIS RUMOR REGARDING THE PARKS AND RECREATION DEPARTMENT: THAT POSSIBLY HE IS LOOKING AT CUTTING THEIR BUDGET IN HALF AND THAT CONCERNS HIM BECAUSE NOT ONLY WILL IT EVENTUALLY INCREASE POLICE OFFICERS, WE ARE GOING TO HAVE A CRIME IN MAYHEM IN OUR CITY AND HE DOES NOT KNOW WHERE HE IS GOING TO BE CUTTING FROM BUT IT DOES NOT SOUND TO HIM LIKE CUTTING HALF OF PARKS AND RECREATION IS A GREAT IDEA AND COUNCILMAN ROSNER STATED THAT HE JUST WANTED TO TELL HIM.

E. COUNCILMAN JULIEN'S REPORT:

1. COUNCILMAN JULIEN STATED THAT IT REALLY GOES WITHOUT SAYING THAT HE WOULD LIKE TO OFFER COUNCILWOMAN SMITH A HEARTFELT CONDOLENCE ON THE LOSS OF HER BROTHER. COUNCILMAN JULIEN STATED THAT HE SPOKE WITH HER SEVERAL TIMES AND HE DOES NOT KNOW WHAT IT IS SHE IS GOING THROUGH. HE CAN JUST IMAGINE FROM THE CONVERSATIONS THAT THE TWO OF THEM HAVE HAD.

E. COUNCILMAN JULIEN'S REPORT - CONTINUED:

2. COUNCILMAN JULIEN STATED THAT HE WOULD LIKE TO THANK THE STAFF OF PARKS AND RECREATION FOR HELPING HIM PUT ON THREE VERY GOOD ITEMS IN THE PAST. THIS MONTH THEY HAD THE MOTHER'S DAY BREAKFAST WHICH WAS A TREMENDOUS SUCCESS. ALSO, SATURDAY AFTERNOON, AT FIVE O'CLOCK, AT THE LITTMAN THEATRE THEY HAD THEIR SECOND ANNUAL, WHAT HE LIKES TO CALL "GREEK FESTIVAL" BUT IT IS A STEP SHOW. COUNCILMAN JULIEN STATED THAT IT WAS AMAZING THAT THE REASON WHY THESE THINGS COME ABOUT TO HIM IS BECAUSE IF YOU KEEP YOUR KIDS INVOLVED YOU TEND TO KEEP THEM OUT OF TROUBLE AND SOME PEOPLE SEEM TO THINK THAT IF YOU THROW MONEY AT A PROBLEM IT IS GOING TO FIX THAT PROBLEM. THROWING MONEY AT A PROBLEM IS NOT THE ISSUE. COUNCILMAN JULIEN STATED THAT HE WALKS AROUND JUST THE GOVERNMENT CENTER HERE ON A REGULAR BASIS AND HE TALKS TO THE PEOPLE WHO HAVE PROBLEMS WITH THEIR KIDS WHO ARE SELLING DRUGS AND THE GANG BANGERS AND THE PROBLEM IS OUR POLICE OFFICERS WILL ARREST THEM AND THEY ARE STILL DOING THE PAPERWORK AND THESE GUYS ARE BACK OUT ON THE STREET AGAIN. SO, IF WE DO NOT RETHINK WHAT IT IS THAT WE DO AS A SOCIETY, YOU CAN THROW AS MUCH MONEY AS YOU WANT AT THAT PROBLEM, IT IS STILL GOING TO BE THERE. THEY HAVE TO FIGURE A WAY TO SUPPORT THE POLICE OFFICERS. WE NEED TO SUPPORT THE POLICE OFFICERS. THEY NEED TO HAVE LAWS THAT
