*F.S. 101.048 STATES, "A PERSON CASTING A PROVISIONAL BALLOT SHALL HAVE THE RIGHT TO PRESENT WRITTEN EVIDENCE SUPPORTING HIS OR HER ELIGIBILITY TO VOTE TO THE SUPERVISOR OF ELECTIONS (IN MUNICIPAL ELECTIONS, THE CITY CLERK) BY NOT LATER THAT 5 P.M. ON THE THIRD DAY FOLLOWING THE ELECTION."
