

# North Miami Beach Police Department Trespass After Warning Program (Instructions)

Dear Property Owner:

In agreeing to participate in our Trespass After Warning Program, you must do the following:

- Complete the enclosed Affidavit of Authorization, including notarization, and return the *original (No copies or faxes will be accepted)* to the:

North Miami Beach Police Department Crime Prevention Unit  
16901 NE 19<sup>th</sup> Avenue  
North Miami Beach, FL 33162

For the police department to enforce the trespassing laws on your property, the Affidavit of Authorization must be signed by the *property owner of record or an authorized individual with power of attorney for the listed property. (Managers, etc. cannot sign the affidavit unless they have power of attorney)*. If the property is a Condominium, a member of the Condo Board must sign the Affidavit of Authorization.

- Purchase the appropriate number of official signs from the North Miami Beach Police Department at a cost of ~~4~~ \$5.00 each. (The property is responsible for the posted of any and all signs. Please post the signs above normal arms reach to avoid graffiti and or vandalism of the signs). We recommend that you post the signs in the areas that you are having a trespassing problem with. (The violators will use the defense that they did not see the sign that warned them not to trespass).
