**a. Water Minimum Charge – based on meter size, per meter**

A charge to provide security and emergency programs for the water treatment plant, water transmission system, and related facilities and resources essential to protect the public welfare.

**d. Private fire service protection**

**e. Hydrant Charge**

A charge to the customer for fire hydrant water service and for the maintenance and repair of fire hydrants. Customers outside the City limits are billed this charge if their property is located within a radius of 660 feet of an existing fire hydrant, as per Miami-Dade County Code.

Monthly customers \$ .10 per bill  
 Quarterly customers \$ .30 per bill

**f. Water Restriction Charge – per 1,000 gallons**

An emergency water restriction charge that varies according to the phase of restriction as declared by South Florida Water Management District. This charge increases based on the phase of water restrictions imposed by SFWMD on the City to achieve the level of reduced water demands. There are four phases starting at 5% (Phase 1=5%, Phase 2=10%, Phase 3=15%, Phase 4=25%).

**STORMWATER CHARGES**

Stormwater charges are a federally mandated utility fee that provides for the installation and maintenance of public swales, pipes, outfalls, and drainage structures that provide for rainwater runoff. The City bills this charge on behalf of the municipality that your account is in.

**MIAMI-DADE COUNTY SEWER CHARGES**

Some customers are provided sewer service by Miami-Dade County, and the City bills for that service on their behalf based on water consumption. The sewer charge is comprised of a minimum charge and a consumption charge.

**MIAMI-DADE COUNTY D.E.R.M. FEE**

All water and sewer utilities in Miami-Dade County are required to pay this fee to support the regulatory and enforcement activities of the Department of Environmental Resources Management. The DERM fee is calculated as 7.5% of the Water/Sewer Minimum, Water/Sewer Consumption, Homeland Security and Water Restriction Surcharge.

**MIAMI-DADE COUNTY EXCISE TAX**

10% tax levied on all water charges of customers within the boundaries of Unincorporated Miami-Dade County, as required by Miami-Dade County (Water Minimum Charge, Water Consumption Charge, Water Restriction Surcharge, and any F.S. 180.191 Water Surcharge).

**UTILITY TAX**

A 10% municipal tax levied on water charges in accordance with Florida Statute 166.231. This tax is collected on all customers within the municipal boundaries of North Miami Beach, Aventura, Sunny Isles and Miami Gardens and remitted to the corresponding municipality. Water charges billed to certain government agencies as exempted by law or court order, are exempt from the tax authorized by Florida Statute 166.231.

**BACKFLOW INSPECTION**

Fees for annual inspection of backflow devices which prevent contaminants from entering the water distribution system.

Residential customers are billed \$6.25 per device, per quarter.

Non-residential customers are billed \$4.17 per device, per month.

**F.S. 180.191 WATER/SEWER SURCHARGE**

A 25% surcharge on Water and N.M.B. Sewer fees to consumers outside the City limits as authorized by Florida Statute 180.191. The 25% Water Surcharge is applied to the Water Minimum, Water Consumption, Homeland Security and Water Restriction Surcharge. The 25% Sewer Surcharge is applied to the N.M.B. Sewer Minimum and N.M.B. Sewer Consumption Charge (it is not applicable to Miami-Dade County Sewer customers).
