e. Hydrant Charge

A charge to the customer for fire hydrant water service and for the maintenance and repair of fire hydrants. Customers outside the City limits are billed this charge if their property is located within a radius of 660 feet of an existing fire hydrant, as per Miami-Dade County Code.

Monthly customers	\$.10 per bill
Quarterly customers	\$.30 per bill

f. Water Restriction Charge – per 1,000 gallons

An emergency water restriction charge that varies according to the phase of restriction as declared by South Florida Water Management District. This charge increases based on the phase of water restrictions imposed by SFWMD on the City to achieve the level of reduced water demands. There are four phases starting at 5% (Phase 1=5%, Phase 2=10%, Phase 3=15%, Phase 4=25%).

Currently based on Phase II water restrictions, 10% of water consumption charge

STORMWATER RATES

Stormwater charges are a federally mandated utility fee that provides for the installation and maintenance of public swales, pipes, outfalls, and drainage structures that provide for rainwater runoff. The City bills this charge on behalf of the municipality that your account is in. These rates are established by each municipality as follows:

Per Equivalent Residential Unit (ERU)	
North Miami Beach – residential	\$ 4.500 per ERU
North Miami Beach – commercial	\$ 5.625 per ERU
Golden Beach	\$ 35.000 per ERU
Sunny Isles	\$ 4.000 per ERU
Aventura	\$ 2.500 per ERU
Miami Gardens	\$ 4.000 per ERU

MIAMI-DADE COUNTY SEWER CHARGES

Some customers are provided sewer service by Miami-Dade County, and the City bills for that service on their behalf based on water consumption. The sewer charge is comprised of a minimum charge and a consumption charge.

NOTE: Miami-Dade County imposed rates that went into effect on October 1, 2009.

A second rate increase will become effective April 1, 2010.
