Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.

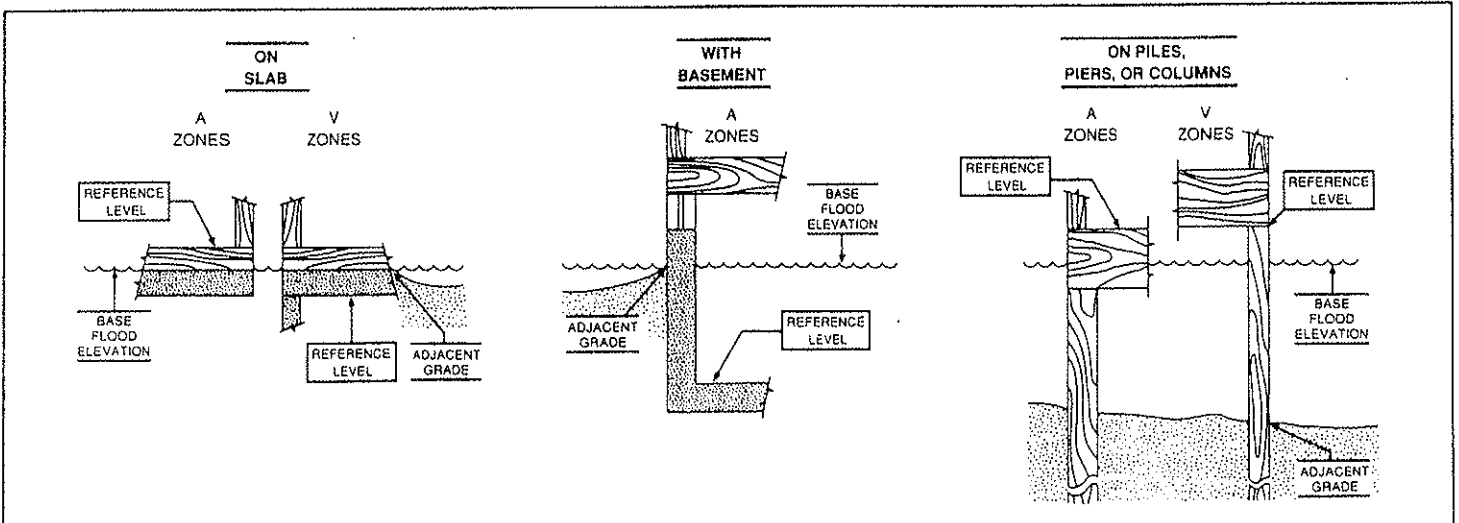

**COMMENTS:** THE REFERENCE LEVEL IS THE FLOOR OF THE ATTACHED GARAGE, WHICH CONTAINS A WATER HEATER AND IS USED FOR THE STORAGE OF HOUSEHOLD GOODS. THE TOP OF THE MAIN GROUND FLOOR OF THE HOUSE IS AT ELEVATION 8.06 FEET.

THE BENCH MARK USED FOR THE SPECIFIC PURPOSE OF OBTAINING FLOOD INSURANCE DATA FOR THIS SURVEY IS A NAIL AND BRASS WASHER IN THE CONCRETE GUTTER ON THE SOUTH SIDE OF THE TRAFFIC ISLAND NORTH OF SUNNY ISLES CAUSEWAY AND WEST OF 35TH AVENUE, ELEVATION 4.82 FEET, BASED ON NATIONAL GEODETIC VERTICAL DATUM OF 1929.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
