- 2. Provide, where necessary, adequate signs, barricades, warning lights, flagmen and/or necessary precautions for the prevention of accidents or injuries to person (s) or property resulting from his (applicant) exercise of the privileges granted under this authorization.
- 3. Repair promptly any and all damages to public or private property caused by his (applicant) exercise of the privileges granted under this authorization. Restoration shall be at least equal to the condition existing at the time of the damage or injury. Temporary patches must be installed adequately and immediately.
- 4. Check with other utility companies for existing underground installations before starting the project. Call Sunshine One Call (**1-800-432-4770**), for marked locations of existing utilities **two working days** (48 hours) prior to excavation.
- 5. Hold the City of North Miami Beach Public Utilities Department and/or the City's employees harmless from any damages resulting from applicant's exercise of the privileges granted under this authorization.
